WHEREAS

We, by the Grace of God, **HI&RM Emperor and King Yuriy I Kostrov, Sovereign King of the Kostrovs Dynastic Imperial & Royal House of the Ukrainian-Rus Kingdom**, The Emperor and King of Kyivan and the Naddniepriansky, of Poltavian and Slobozhanian, Podillian and the Carpathians, Zaporozhzhian and Odessian, Polissian and Kubanian and all Ukraine-Rus, Khan-Khuu of the Golden Horde, Kazan and Crimea, Grand Duke of Jerusalem and Prince of Rus, Kagan-Bek of the Khazars, Archduke de Baixo Alentejo of Portugal de Burgundy-Afonsina, Prince de Avis of Portugal and Duke de Beja, Grand Duke de Greoux and Grand Duke de Joubar, Grand Duke of the Holy Catholic Empire and Grand Duke de San Isidro, Duke of Burgundy and King of the Sultanate of Kapatagan Valley, King of Tambang Terantang and Kampar, among others.

Dynastic DUX REX and REX ORDINIS, MAGISTER MAGNUS ULTIMUS - NOSTRUM CLAVIGER, Supreme Commander-in-Chief of the Imperial & Royal Knights Order of the Blood of Christ, Grand Master of the Dynastic Order of Knights of the Temple of Avis, MAGISTER MAGNUS ULTIMUS - NOSTRUM CLAVIGER of the Dynastic Ancient Knights Order of King David, Grand Collar of the Venerable Order of the Holy Redeemer, Supreme Hetman of the Ukraine-Rus and the Imperial Cossack Army (Order), among others.

And by the Grace of God **HRH Sovereign Prince Carl Raymond David Bradley**, of the Cenel Bhrolchan, of the Cenel Fearadhaigh, of the Cenel Eoghain, Kingly-Prince of the Cenel Bhrolchan, and the Royal House of Bradley have mutually entered into negotiations and concluded this Treaty of on the mutual recognition of all historical and acquired Titles of Nobility and all their dynastic and other Knightly Orders, about friendship between above indicated August Houses, economic and diplomatic cooperation, environmental protection, mutually beneficial trade and other business, the struggle for peace and free navigation, and who, having exchanged all their powers, found all this set out in good and proper form, concluded and signed the following Articles of this Treaty:

Article I

There shall be perpetual peace and friendship between HI&RM Emperor and King Yuriy I Kostrov, the Sovereign King of the Kostov's Imperial & Royal House of the Ukrainian-Rus Kingdom and all his successors and HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley and all his successors.

Article II

The HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom and HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley and their descendants acknowledge this Treaty is in full effect and force.

Article III

HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom acknowledges of HI&RM King-Emperor Carl Raymond David James Ernst Bradley, the Head of the Imperial House of Bradley as well as all his hereditary and other Titles of Nobility, his dynastic and other Knightly Orders, signs, banners and Coats of Arms.

Article IV

HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley acknowledges HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov Imperial & Royal House of the Ukraine-Rus Kingdom as well as all his hereditary and other Titles of Nobility, his dynastic and other Knightly Orders, signs, banners, Coats of Arms, and that he is the legitimate Sovereign King of the Ukraine.

Article V

HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom on behalf of the Ukraine-Rus Kingdom, acknowledges that the HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley is sovereign over all lands in the his Kingdom and all waters customarily under the sovereignty of nations, such as the norm established by the United Nations Convention on the Law of the Sea (1982) recognizing maritime territories extending 12 nautical miles (22 kilometers) from the coastlines of each island and the Exclusive Economic Zone extending special rights of sovereignty out to 200 nautical miles established by the same agreement.

Article VI

HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley acknowledges that the HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House on behalf of the Ukrainian-Rus Kingdom is sovereign over all lands in the Ukraine and all waters customarily under the sovereignty of nations, such as the norm established by the United Nations Convention on the Law of the Sea (1982) recognizing maritime territories extending 12 nautical miles (22 kilometers) from the coastlines of each country or island and the Exclusive Economic Zone extending special rights of sovereignty out to 200 nautical miles established by the same agreement, recognized by the United Nations.

Article VII

HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom acknowledges that the HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley devoted to the furtherance of peace and reconciliation among the nations of the world and within the entire Human Family. HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House on behalf of the Ukrainian-Rus Kingdom, shares in the desire for peace and reconciliation and pledges to cooperate HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley in the pursuit of that goal. HI&RM King Yuriy I Kostrov, Sovereign King and on behalf of the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom recognizes the right of HI&RM King-Emperor Carl Raymond David James Ernst Bradley, to forbid the operation or establishment of foreign military bases within the sovereign lands and waters of his Kingdom, except in situations of insuperable circumstances. The HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom, pledges to oppose any attempt by any other nation to infringe on the sovereignty of HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley and to join with other nations who have made a similar pledge to pursue such opposition.

Article VIII

HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley acknowledges that the HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House on behalf of the Ukrainian-Rus Kingdom devoted to the furtherance of peace and reconciliation among the nations of the world and within the entire Human Family. HI&RM King-Emperor Carl Raymond David James Ernst Bradley, the Head of the Imperial House of Bradley, shares in the desire for peace and reconciliation and pledges to cooperate with HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom in the pursuit of that goal.

HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley recognizes the right of HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom, to forbid the operation or establishment of foreign military bases within the sovereign lands and waters of the Ukraine-Rus Kingdom, except in situations of insuperable circumstances. HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley, pledges to oppose any attempt by any other nation to infringe on the sovereignty of HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom and to join with other nations who have made a similar pledge to pursue such opposition.

Article IX

HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom and HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley share a common goal of developing sustainable civilizations that ensure a healthy, diverse, and abundant ecological heritage for future generations and pledge mutual cooperation in the pursuit of that goal.

Article X

There shall be reciprocal liberty of sustainable commerce and navigation between the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom and HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley. The rules of commerce shall be negotiated in the context of a mutual agreement that all commerce contributes to the development of sustainable civilizations in both nations and local self-reliance to the greatest extent possible.

Article XI

HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House of the Ukrainian-Rus Kingdom and HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley agree that, while within one nation or the other, citizens or subjects of both nations shall enjoy complete freedom of religious or spiritual belief and conscience without being disturbed or molested because of their beliefs.

Article XII

The parties mutually agree to surrender, upon official requisition, to the authorities of each, all persons who, being charged with the crimes of murder, piracy, arson, robbery, securities fraud or similar economic crime, forgery, or the issuance of forged paper, committed within the jurisdiction of either, shall be found within the territories of the other, provided that this shall only be done upon such evidence of criminality as, according to the laws of the place where the person so charged shall be found, would justify his or her apprehension and commitment for trial, if the crime had there been committed; and the respective judges and other magistrates of the two governments shall have authority, upon complaint made under oath, to issue a warrant for the apprehension of the person so charged, that he or she be brought before such judges or other magistrates respectively, to the end that the evidence of criminality may be heard and considered; and if, on such hearing, the evidence be deemed sufficient to sustain the charge, it shall be the duty of the examining judge or magistrate to certify the same to the proper executive authority, that a warrant may be issued for the surrender of such fugitive. The expense of such apprehension and delivery shall be borne by the party who makes the requisition and receives the fugitive.

Article XIII

The present Treaty shall be in force from the date of the exchange of ratification, for the term of ten years, and further, until the end of twelve months after either of the contracting parties shall have given notice to the other of its intention to continue an additional term or to terminate the same, each of the said contracting parties reserving to itself the right of giving such notice at the end of said term or ten years, or at any subsequent term.

Article XIV

Any citizen or subject of either party infringing the Articles of this Treaty shall be held responsible for the same, and the harmony and good correspondence between the two Royal Houses governments shall not be interrupted thereby, each party engaging in no way to protect the offender or sanction such violation.

Article XV

The present treaty shall be ratified by HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House on behalf of the Ukrainian-Rus Kingdom by and with whatever advice or consent that nation's governing rules require and by HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley, by and with the advice of his Ministers.

SUMMARY

Both HI&RM King Yuriy I Kostrov, Sovereign King of the Kostrov's Imperial & Royal House on behalf of the Ukrainian-Rus Kingdom and HRH Sovereign Prince Carl Raymond David Bradley, the Head of the Royal House of Bradley recognize each in his own state is a sovereign and independent, and as a whole lead formal diplomatic, royal, humanitarian, business and spiritual relations in their respective Kingdoms.

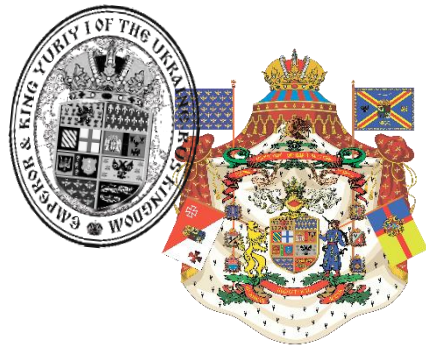
